	 be established as an enterprise according to Romanian Law 31/1990 and to have its registered office in the North-East region; not be in situations of exclusions by de minimis aid regulation; be active for a period corresponding to at least one full fiscal year, did not have the activity temporarily suspended at any time in the year of submitting the financing request and in the previous fiscal year, and recorded operating profit (>0 lei) in the fiscal year preceding the submission of the financing request; to have property rights or rights of use over the property/properties and other movable and/or immovable property necessary, as the case may be, which are the subject of the project; have a NACE code from division 72 (Research-Development) registered in the object of activity, regardless of whether it represents the main or secondary activity of the enterprise; have registered in the object of activity one or more NACE codes associate(d) to the area(s) of North-East smart specialization connected with the investment.
