	 be classified in the SME category following the EC definition; be established as an enterprise according to Romanian Law 31/1990; be registered in the North-East region (at the latest at the time of the first payment of aid); be active for a period corresponding to at least one full fiscal year, did not have the activity temporarily suspended at any time in the current year of submitting the financing request and in the previous fiscal year, and recorded operating profit (>0 lei) in the fiscal year preceding the submission of the financing request; have a NACE code from division 72 (Research-Development) authorised; have at least 1 registered employee in the last fiscal year; not to be excluded by de minimis aid regulation.
	To be eligible for this call for projects, the project must:
	 have an approved Project Fit Form in the VInnovate call 2025; target at least one of the smart specialization domains of the North-East Region; target specific activities of TRL 6-TRL 8 stages for the development of a product or process; not include activities in sectors excluded from the scope of de minimis aid regulation; be implemented in the North-East region; respect the DNSH principle.
