# VI Innovation Policy Conference Shaping an Ambitious EU Innovation Agenda to accelerate the twin green and digital Transitions

# This Vanguard Initiative Policy Conference will facilitate an expert panel discussion to reflect on how the urgent need to accelerate on the green and digital transition calls for an ambitious and comprehensive EU innovation agenda.

Panel discussions will put in light how the EU Industrial Strategy would benefit from an active EU innovation policy with EU Innovation ecosystems development as cornerstone, and to what extent a strong EU Internal Market is essential to support interregional collaboration.

In this context, the conference will highlight the pivotal role of EU Innovation ecosystem development and its fundamental interregional dimension, how it can be enhanced through an ambitious EU innovation policy, and why it is critical to shaping a successful EU industrial policy in a currently shifting and uncertain geopolitical context.
